IL&FS Engineering and Construction Company Limited (IL&FS Engineering Services) has received a Letter of Intent (LoI) from Madhyanchal Vidyut Vitran Nigam Limited (MVVNL) for Rural Electrification (RE) works of majre/villages of Gonda district in Uttar Pradesh on a turnkey basis under Government of India Scheme of *Deen Dayal Upadhyay Gram Jyoti Yojana (DDUGJY)*. The total value of this contract is **Rs. 149.22 Crores**, and the project completion period is 12 months from the date of issue of the LoI.

As part of this Scheme, 1436 villages of Gonda district will be electrified that will result in provision of 39600 Nos. of Services Connections to Below Poverty Line (BPL) card holders. This project is funded by REC under the Eleventh Plan Programme.
