Chainage 90.615 Km. at Koottanad including Station Works at Dispatch Terminal at existing IP Station-1, SV-1, SV-2, SV-3, SV-4, & SV-5, and IP Station-1 at Koottanad of ***Kochi-Koottanad-Bangalore-Mangalore Pipeline Project*** Phase-II in Kerala.

The total length of the 30” pipeline is 91 Km. The total value of the Contract is **Rs. 173.13 Crores** (plus Service Tax), and is to be mechanically completed in 24 months from date of FOA and with additional 2 months for commissioning and GAS-IN.
